We are delighted to share this first annual impact report as **Reproductive Health Collaborative Nebraska** (RHCN), our new brand, which launched in Fall 2024.

While much was accomplished in the first five years of our history as the Family Planning Council of Nebraska, we have made a significant leap forward as RHCN, evolving as a leading voice and champion for sexual and reproductive wellbeing across our state.

This is a pivotal moment in our field as we work to counter increasing attacks on access to care, contraceptives, and freedom of choice, while also facing significant declines in federal funding and resources. We are resolved in our mission to ensure access by working in partnership with the clinics we fund and other partners in the field who have created an important foundation for the work ahead.

Through our collaborative network of 10 dedicated healthcare agencies staffing 30 clinical sites statewide, nearly 24,000 Nebraskans received unbiased, culturally sensitive, and medically accurate care last year through nearly 35,000 visits. This includes important cancer screenings, STI testing

and treatment, contraception, fertility and pregnancy counseling, and referrals.

Throughout RHCN's short history, our work has advanced clinical best practice, essential sex education, honest community conversations, and advocacy for critical public policy.

Our team invites you to learn more about our mission and work in these pages. We also encourage you to raise your voice in partnership with RHCN and our tremendous supporters who are committed to advancing access to high-quality care and resources statewide for all Nebraskans.

Who We Are

We envision a Nebraska in which *all* people have access to **high-quality, affordable sexual and reproductive healthcare** and the unbiased information and conversations that contribute to their well-being.



ABOUT US

Reproductive Health Collaborative Nebraska (RHCN) bridges the advancement of health equity with high-quality sexual and reproductive healthcare through robust support, education, and advocacy.

RHCN became Nebraska's sole federal Title X grant administrator in 2019, providing funding, training, resources, oversight, and more, via the 55-year-old bipartisan program.

In 2023, we launched our privately funded effort, the Sexual & Reproductive Health Initiative (SRHI), an evolution of the Contraceptive Access Project, to further support our existing work and increase access in Nebraska.

By braiding public and private funding sources, we engage and support a network of 10 healthcare agencies with 30 clinical sites statewide—from Omaha to Chadron.

Since 2019, our network of clinical provider partners has served more than **141,540 clients**.




Who We Serve

Championing equitable access to quality sexual and reproductive care means RHCN's work benefits *all* Nebraskans.

As we strive to improve individual health outcomes, families and communities benefit as well. This often means protecting access for low-income and uninsured/underinsured individuals, as well as people from historically marginalized communities.





Strategies & Programs

Five essential elements anchor our work and propel our mission: **Healthcare Services Investment, Clinical & Community Education, Public Policy, Learning & Evaluation, and Community Engagement**—with an overall approach of **innovation** woven throughout each strategy.



HEALTHCARE SERVICES INVESTMENT

This year, RHCN invested \$5,838,649 in partner agencies. In response to federal funding delays and cuts, we **tailored investments to unique agency needs** this year. We continued to nurture a **unified provider network**, balanced funding and technical support, and provided reviews and training to align each agency's **schedule of rates for healthcare services**.

Whether a member was a larger federally qualified health center or a smaller, stand-alone facility, we **strategically adjusted** based upon their situation.

CLINICAL & COMMUNITY EDUCATION

RHCN expanded our **Training Center** this year, by facilitating four clinical trainings and ongoing 1-on-1 **clinical staff** consultations, plus four trainings for education & outreach staff. We also hosted clinical roundtables, community of practice meetings, and coalition convenings. We emphasize sexual and reproductive health and well-being education that's **unbiased, medically accurate, trauma-informed, and culturally competent**, and function as one of Nebraska's largest funders of **sex education**.

PUBLIC POLICY

During the 2025 Nebraska legislative session, we progressed our efforts to **support policies that would create optimal conditions for healthcare access and equity** by tracking key legislation, submitting testimony, and supporting the policy efforts of our **peer nonprofits**. Our team also connected with **Nebraska's state and federal delegation**, providing data and information to help them better understand the urgent need to protect crucial state and federal **Title X funding**.

LEARNING & EVALUATION

This year, we began a mixed-method, collective impact-based **Statewide Sexual and Reproductive Health Assessment** to explore access to services and information, and to assess client clinic experiences, self-efficacy, and attitudes toward SRH. Results will **inform future planning, strategies, and programming**, and will be shared with organizations/stakeholders statewide in early 2026.

We also continued to gather, evaluate, and share the **unique client trendline data** generated within our clinical network, reporting **Data Snapshots** twice annually.

COMMUNITY ENGAGEMENT

In addition to the **RHCN rebrand and new website launch**, we created a secure, 24/7 **agency portal to support our clinical partners in their work** and relationship with the collaborative.

Through our client-facing [**In Control Nebraska**](#) initiative, our team helped launch a **statewide billboard campaign**, created and delivered **client education materials** for partner clinics, and continued to **educate clients statewide on sexual health and well-being**.

We enhanced partnerships with a **Nebraska-based "Hello Tour"**—meeting with 45+ private and public organizations and entities whose work intersects with ours to **spark and encourage collaboration, information flow, and mutual support**.

Our team also **engaged deeply at the national level**, via regular meetings and strategy sessions with the **Family Planning Councils of America and the National Family Planning and Reproductive Health Association**.

RHCN also convened a quarterly meeting regarding **emergency contraception with five Nebraska nonprofits** and invited greater involvement, collaboration, and thought leadership from our **Community Advisory Council**.

August 2025: Members of the Community Advisory Council meet for an annual retreat to co-create a series of short video clips intended to help start conversations about sexual and reproductive health with partners and healthcare.





On the Horizon

Whether working on upstream solutions or addressing acute community needs, our team is often on the cusp of our next proactive plan or inventive ideation to nurture, improve, and evolve our work. Here's some of what to expect from Reproductive Health Collaborative Nebraska in the coming year.



EXPANDING OUR TRAINING CENTER

We're enhancing this essential resource for clinical providers, administrative support staff, and educators to provide **even more robust opportunities for evidence-based, medically accurate, and up-to-date information to power their work.**

In the coming year, we'll cover topics like trauma-informed care, perimenopause and menopause, GLP-1s and contraceptive effectiveness, legislative advocacy for healthcare professionals, improving front desk processes, how sex educators can combat misinformation and build media literacy, and more. We'll also offer more **public training and education opportunities!**

ENHANCED TREND-TRACKING & DATA SHARING

In 2026, RHCN will release our **Statewide Sexual and Reproductive Health Assessment**, which will inform our organizational strategies and offer key insights to partners and stakeholders. We've collaborated with reproductive health and data experts statewide and nationally to explore Nebraskans' sexual healthcare needs and experiences. Our team also plans to **more regularly share from the trove of statewide and national data** we compile and evaluate.

INCREASED ADVOCACY WORK

We'll continue to **advocate for state and federal policy that promotes sexual and reproductive health** and the delivery of quality care—with increased focus and capacity. In July 2025, a **Policy Fellow** joined our team, with generous support from the Nebraska Civic Engagement Table. Through advocacy and communications, we'll facilitate opportunities for all Nebraskans to **better understand and champion** policies that support equitable access to quality sexual and reproductive healthcare.

STREAMLINED EDUCATION & OUTREACH

Sexual and reproductive health education should be **medically accurate, inclusive, trauma-informed, high-quality**, and easy to understand and access. Heightened misinformation and disinformation increase the need for media literacy and fact-based information. Our clinical network's education and outreach efforts currently reach approximately 31,000+ people annually through facilitated education and outreach events and off-site STI testing.

Our team is working on an **enhanced, centralized approach for 2026** and beyond to **combat misinformation and disinformation** to arm Nebraskans with essential knowledge, ultimately **optimizing health outcomes**.

BUILDING LOCAL & NATIONAL PARTNERSHIPS

Our continued "Hello Tour" will introduce **aligned organizations** and entities, **nurturing even more strategic collaboration statewide**. From education and the public sector to nonprofits, clients, and other uniquely positioned subject matter experts, we want a multitude of voices at the table for the benefit of all Nebraskans. To that end, 2026 will bring **more opportunities for Nebraskans to learn about and engage in our work** at special events statewide.

Nationwide, we'll advance more exciting work with **nationally recognized consultants and a cohort from the National Family Planning and Reproductive Health Association**.

SEXUAL & REPRODUCTIVE HEALTH BOOK CLUB

Book nerds and sexual and reproductive health enthusiasts, rejoice! In 2026, we plan to host an **affirming space to discuss titles pertinent to our work**.

Dive deep with us, because **knowledge is power and community is everything**.

GROWING COMMUNITY SUPPORT
